- Current PK-12 Families: Please do not complete NEW APPLICATIONS FOR the 2024-2025 school year. Your re-enrollment packet is located on your FACTS Family Portal PARENTS WEB. If you have not set up your RenWeb account, please do so as re-enrollment will require access to your account.

- PK-12 New Student Enrollment 2024-2025 is open.
- Families who have a hold on their accounts will need to call the office to make an appointment to come in to re-enroll.

#### PK-12 Incentives

~"Bring a Buddy" Incentive: Any family who brings a new family to CC who is accepted for the 24-25 school year will receive an adult athletic pass for the 24-25 school year.

~January 5 to January 31 is early registration for returning families if you enroll K-12 student(s)

~February 1 to March 28 early registration. Families will receive \$100 off the \$250 for one K-12 registration fee.

~March 28 to June 1 \$50 off the \$250 for one K-12 registration fee

~ All preschool families who re-enroll/enroll by Feb. 29, 2024, will receive \$25 off of the \$100 registration fee.

***\*PK-12 Incentives are for one child.***

Due to the school delay, we had on January 25th, the zoo assembly for grades K-6 has been rescheduled. The Columbus Zoo will now visit us on May 9th!



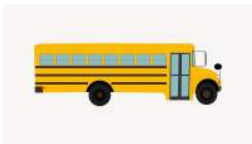
**SAVE THE DATE- Feb 16, 2024**
